

NTGPE guidelines for management of ADF GP registrars

NTGPE is aware of the challenges faced by GP registrars who are training whilst also working as a member of the Australian Defence Force.

The staff at NTGPE and Northern Health Command work together to ensure that ADF GP registrars working and training in the Northern Territory are given the best GP training experiences, taking into account the unpredictability and constraints of their ADF role.

NTGPE's education leadership team will work collaboratively with each GP registrar to ensure that appropriate activities are counted towards training, whilst also ensuring that education, training and supervision requirements are met and the overall training experience is of high quality.

The table below outlines the NTGPE guidelines for management of ADF GP registrars who are unable to be released for full time GP registrar training.

	Formative ECTV /MiniCEX	Five in total, with one a video	No change.
Payment	Exams / Assessments	RACGP 3 x exams (AKT, KFP and OSCE) ACRRM – CBD, MSF, PC STAMPS	No change.
			GP Registrar receives normal pay from ADF. The training post keeps any Medicare revenue. If ADF GP registrar wishes to work at the civilian clinic outside normal base hours then this will be outside the GP registrar training program and the registrar should arrange an employment contract etc. as an independent worker.
